Strategy description

As a high risk investor your portfolio will be invested primarily in equities. This approach concentrates on achieving a good overall return on your investment, whilst avoiding the most speculative areas of the market. Significant short term fluctuations in value can be expected. The eventual return for the period over which you wish to invest could fall within a relatively wide range of possibilities. In most circumstances, particularly over periods in excess of five years, the return should compare favourably with that achievable from a more conservative approach.
